Notice of Race

The Organising Authority is the Evans Bay Yacht and Motor Boat Club (EBYMBC)

1. Rules

- 1.1. Club Racing will be governed by the rules as defined in the Racing Rules of Sailing 2017-2020 (RRS).
- 1.2. The YNZ Safety Regulations Part 1 (published in Racing RRS, 2017-2020) shall apply to all centreboard and open yachts, sailboards and ballasted yachts not complying with the YNZ Safety Regulations of Sailing 2017-2020, (SRS), Parts II – VI.
- 1.3. The SRS Parts V & VI, Category C, shall apply to all trailer yachts and all sports trailer yachts.
- 1.4. Ballasted centreboards shall be locked fully down at all times while racing. This changes SRS Part V, Clause 7.06.
- 1.5. All cruising boats shall comply with SRS Part II Category 5, except that all boats shall, while racing, operate a VHF radio capable of receiving Race Committee instructions on VHF channel 77. This changes SRS Part II Category 5, Clause 18. Failure to receive instructions will not be grounds for redress.
- 1.6. RRS 41 is changed to include:

“coaching of a non-tactical nature by a YNZ Instructor or YNZ coach”.
- 1.7. For protests where only a rule of RRS Part 2 or RRS 31 is alleged to have been broken, an arbitration hearing may be offered prior to any formal protest hearing.

2. Advertising

- 2.1 Advertising is permitted as per the Class Rules.
- 2.2 Boats may be required to display advertising chosen and supplied by the Organising Authority.

3. Eligibility and Entry

- 3.1. The regatta is open to all boats that comply with SRS 2017-2020 and their Class Rules. If insufficient entries are received to make up a class (a minimum of 5 yachts), yachts will be grouped into Open Classes.
- 3.2. Eligible boats may enter by completing the attached entry form accompanied by a fee of \$30.00 per boat for the series, or \$10 per race day.
- 3.3. To be eligible to compete in this event each competitor shall be a financial member of a club recognized by Yachting New Zealand.

4. Schedule

4.1. Race Schedule: *Race Days are scheduled as follows:*

Saturday 17 June	Saturday 1 July
Saturday 15 July	Saturday 29 July
Saturday 12 August	Saturday 26 August

- 4.2. Six races, one per race day, are scheduled for the Cruising/Keeler Division.
- 4.3. Twelve races, two per race day, are scheduled for all other Divisions.
- 4.4. The Race Committee may sail one race in addition to the races scheduled for that day. The additional race shall be the re-scheduling of a postponed race.
- 4.5. The warning signal for the Cruising/Keeler Division will be at 1245hrs each race day. The first warning signal for all other Divisions will be at 1255 hours each race day.

5. Sailing Instructions

5.1. The sailing instructions will be available on the EBYMBC website after 1 June 2017 for sailors to print off for their own use. A copy of the sailing instructions will be posted on the official noticeboard located on the eastern deck of the clubhouse.

6. Venue

6.1. The Regatta Venue is the Evans Bay Yacht & Motor Boat Club (EBYMBC). Refer to Attachment B.

6.2. The Racing area is the waters known as Wellington Harbour, primarily within Evans Bay.

7. Courses to be Sailed

7.1. The courses to be sailed and course diagrams will be displayed on the course board located on the eastern deck of the clubhouse.

8. Penalty System

8.1. Rules 44.1 and 44.2 are changed so that the 'Two-Turns' penalty is replaced by the 'One-Turn' Penalty.

9. Scoring

9.1. 1 race is required to be completed to constitute a series.

9.2. When fewer than 7 races have been completed, a boat's series score will be the total of her race scores.

9.3. When from 7 to 11 races have been completed, a boat's series score will be the total of her race scores excluding her worst score.

9.4. When 12 races have been completed, a boat's series score will be the total of her race scores excluding her two worst scores.

10. Launching

10.1. Unless otherwise directed by the organising authority, all dinghies shall be launched and retrieved at the direction of Club representatives from the ramps adjacent to the EBYMBC.

11. Coaching and Support Boats

11.1. All coaching and support boats must carry a VHF radio transceiver capable of receiving and transmitting VHF channel 77 and must assist the Race Committee as directed if required.

11.2. Further information will be provided to registered boats by the Organising Authority or Race Committee.

12. Radio Communication

12.1. Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

13. Prizes

13.1. Prizes will be awarded as follows:

13.2. Other prizes may be awarded at the discretion of the Race Committee.

14. Disclaimer of Liability

14.1. Competitors participate in all races entirely at their own risk. Refer to RRS rule 4. The Organising Authority will not accept any liability for material damage or personal injury or death sustained in conjunction with, prior to, during, or after the race.

14.2. Competitors accept that sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk. By taking part in the event, each competitor and the responsible adult agrees and acknowledges that:

- They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves and their boat to such inherent risk whilst taking part in the event;
- They are responsible for the safety of themselves, their boat and their other property whether afloat or ashore;
- They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omission;
- Their boat is in good order, equipped to sail in the event and they are fit to participate;
- The provision of a race management team, support boats and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- The provision of support boat cover is limited to such assistance, particularly in extreme weather conditions, as can be practically provided in the circumstances.

15. Insurance

15.1. All entrants shall have third party liability insurance cover of not less than NZD\$100,000. Proof of insurance must be provided if requested.

16. Rights to use name and Likeness

By participating in the regatta competitors automatically grant to the Organising Authority, and their sponsors, the right in perpetuity to make, use and show, from time to time at their discretion, any motion pictures and live, taped or filmed television and other reproductions of the athlete during the period of the competition without compensation.

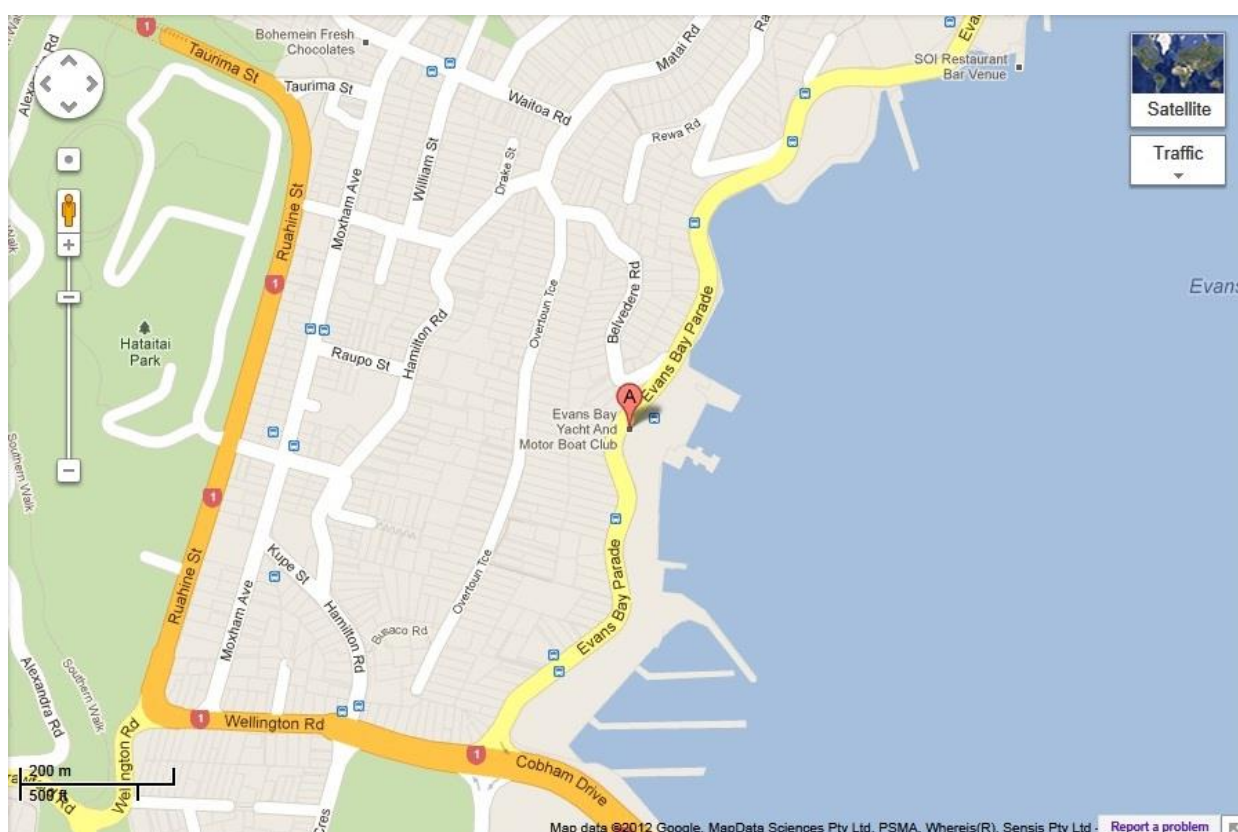
